This Agreement governs Customers' use of LINEAR TECHNOLOGY CORPORATION'S On-Chip Software Development Kit (SDK) for development of applications that run on the Integrated Circuits (ICs) of its related company, DUST NETWORKS. LICENSEE'S download and use of the SDK Software Zip file shall constitute Licensee's conclusive, irrefutable and irrevocable consent to be bound by the terms and conditions set forth below.

1. **DEFINITIONS**

When used in this Agreement, the below defined words are limited to the following meanings:

- **1.1 "Customer Application"** means any application code or generated data file derived or created by the Licensee using the Software, including without limitation any portions or components of larger applications.
- **1.2 "Documentation"** means the Software user manual(s), software-enabled help files, advice available from that is provided on-line or through the Internet, together with such other Software literature that may be provided by to License by DUST NETWORKS.
- **1.3 "Customer Development Platform"** means a computer system running any operating system used to develop the Customer Application.
- **1.4 "Target Platform"** means a DUST NETWORKS SmartMesh product family low power wireless IC having DUST NETWORKS SmartMesh Network protocol stack.
- **1.5 "Licensee"** means that licensed individual, organization or entity that is a user of the SDK Software excluding any of Licensee's affiliates, parent corporations, subsidiaries, and other organizations, divisions and groups, and in some cases locations unless specifically identified herein or by separate agreement.
- 1.6 "Software" means the DUST NETWORKS software tools, the SDK Software and other software programs developed at private expense by DUST NETWORKS and other third party supplier software programs (each tool or software program a Component). Components that Licensee receives as part of the Software may include a separate enduser license agreement. With the exception of Licensee's separate license to the Dust Networks SmartMesh Network protocol stack (the terms and conditions of which shall control in the event of inconsistency with this License agreement), in the event of inconsistencies between this License Agreement and any Component License Agreement, the terms of this License Agreement shall control. Where the Software contains third party software programs, such third party software is provided for Licensee to use as a convenience and Licensee's use is subject to the terms and conditions of any license agreement contained in that software.

2. LICENSE GRANT, RIGHTS AND LIMITATIONS

- **2.1 General License Grant.** DUST NETWORKS grants to Licensee as an individual, a personal, nonexclusive license to use the SDK Software, and to make and use copies of the Software for the purposes of designing, developing, testing, and demonstrating Licensee's software applications and writing those applications directly on the Target Platform, on top of DUST NETWORKS Smart Mesh Network protocol stack.
- **2.2 Customer Application Development.** Subject to the terms and conditions of this Agreement and payment of all applicable license fees, Licensee is hereby granted a non-exclusive, non-transferable license with the all the rights and limitations of use, limited warranties, terms, conditions, and prohibitions of this Agreement. Licensee may create derivative works and create an unlimited number of Customer Applications for use on the Target Platform using the SDK Software provided that the Customer Application(s) protect DUST NETWORKS proprietary rights and credit DUST NETWORKS by ensuring that all DUST NETWORKS copyrights, trademarks, limited use rights, logos, and other proprietary legends and notices are reproduced in the Customer Application(s). All terms and conditions as stated below for Target Platform apply.

3. PERMITTED USE OF SDK SOFTWARE

- **3.1** The Licensee Applications made using the SDK Software may be modified by the Licensee for use in embedded applications and Customer Applications, which may be copied and distributed on the Target Platform as permitted in this License.
- **3.2** Except as provided hereinabove, the SDK Software may otherwise not be copied or used by Licensee. In no case may the Licensee distribute any SDK Software or Documentation in a stand-alone form.

4. SOFTWARE WARRANTY

- 4.1 General. The Software Warranty, Remedies, and Exclusions are applicable to all licensed Software components purchased without a separately purchased Software Support Agreement.
- **4.2 Limited Warranty.** DUST NETWORKS warrants that the Software, including the SDK Software, for a period of ninety (90) days after Licensee's download of a zip or other file comprising the SDK Software, and that the Software when properly installed and used according to the applicable Documentation, will perform in substantial conformance to the stated specifications provided in the Documentation (with nonconformance to be determined and established by DUST NETWORKS exclusively via applicable DUST NETWORKS performance verification testing).
- **4.3 Remedy for Nonconforming Software.** If, during the applicable Warranty Period, (a) the SDK Software does not substantially conform to the applicable specifications provided in the Documentation, (b) such non-conformity materially affects the

functionality of the SDK Software, and (c) DUST NETWORKS receives notice of such non-conformity in writing via the support email address DustCloud@linear.com, DUST NETWORKS will use reasonable commercial efforts to remedy the nonconformity by repairing or replacing the non-conforming SDK Software. In the event repairing or replacing the SDK Software is not commercially reasonable, DUST NETWORKS may, at its sole discretion, terminate the license to the SDK Software. The remedies set forth herein shall be Licensee's sole and exclusive remedy, and DUST NETWORKS entire liability for breach of this limited warranty.

4.4 Exclusions. The foregoing warranties do not apply to any non-conformance in the SDK Software (a) resulting from modifications, repairs or alterations, except by DUST NETWORKS or its authorized representative; (b) resulting from other hardware or software products; (c) caused by a product for which DUST NETWORKS is not responsible; (d) associated with any non-DUST NETWORKS products, including those that DUST NETWORKS may procure and provide with or integrate with the SDK Software at Licensee's request; (e) caused by operation or use of the SDK Software outside of its intended use as provided in the SDK Software documentation; (f) caused by misuse, abuse, negligence, accident or as a result of being subjected to unusual physical, electrical or environmental stress; or (g) if the affected SDK Software has not been maintained in accordance with all handling, operating and maintenance instructions supplied by DUST NETWORKS. Additionally, the warranties set forth herein do not apply (i) to error corrections or updates of the SDK Software after expiration of the limited Warranty Period (ii) demonstration or evaluation copies of the SDK Software, or (iii) if the SDK Software product identification or proprietary markings have been removed or altered.

5. DISCLAIMER OF OTHER WARRANTIES

To the fullest extent allowed by law, the foregoing warranties and remedies are exclusive and are in lieu of all other remedies, warranties, terms, or conditions, express or implied, either in fact or by operation of law, statutory or otherwise. DUST NETWORKS warranties herein extend to Licensee only, and not to any other third parties. DUST NETWORKS neither assumes nor authorizes any other person to assume for it any other liability in connection with the sales, installation, maintenance or use of the Software or performance of services. Replacement SDK Software assumes the warranty status of the Software being replaced and has no separate or independent warranty of any kind. Because the SDK Software is inherently complex, DUST NETWORKS makes no warranties or representations that the operation of the SDK Software will be uninterrupted or error free, or that the Software or the results produced will meet Licensee's needs or expectations. OTHER THAN AS EXPRESSLY SET FORTH ABOVE, THE SOFTWARE IS PROVIDED "AS IS" AND DUST NETWORKS MAKES NO WARRANTIES, EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE. DUST NETWORKS SPECIFICALLY DISCLAIMS THE IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, SATISFACTORY QUALITY, ACCURACY, AND NON-INFRINGEMENT, TO THE MAXIMUM EXTENT PERMITTED BY LAW.

6. LIMITATION OF LIABILITY

DUST NETWORKS, OR ITS AFFILIATES' OR ITS SUPPLIERS' TOTAL LIABILITY ARISING UNDER OR IN CONNECTION WITH THIS LICENSE SHALL BE LIMITED TO DIRECT, ACTUAL DAMAGES UP TO BUT NOT TO EXCEED THE PURCHASE PRICE OF THE SOFTWARE LICENSE. IN NO EVENT SHALL DUST NETWORKS BE LIABLE FOR COSTS OF SUBSTITUTE PRODUCTS OR SERVICES, LOST PROFITS OR REVENUE, BUSINESS INTERRUPTION, CLAIMS OF THIRD PARTIES, LOSS OF INFORMATION ARISING OUT OF THE USE OF OR INABILITY TO USE THE SOFTWARE, OR ANY SPECIAL, INDIRECT, RELIANCE, CONSEQUENTIAL, INCIDENTAL OR PUNITIVE DAMAGES, HOWEVER CAUSED AND ON ANY THEORY OF LIABILITY REGARDLESS OF THE REASON. THE FOREGOING LIMITATIONS SHALL APPLY REGARDLESS OF WHETHER DUST NETWORKS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND NOTWITHSTANDING THE FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY. The disclaimers of warranty and limitations of liability set forth herein are an essential element in setting the product price. Because some states and jurisdictions do not allow the exclusion or limitation of liability for consequential or incidental damages, the above limitation may not apply or fully apply to Licensee.

7. LICENSE RESTRICTIONS

- **7.1** Licensee shall not modify, adapt, translate, rent, sublease, assign, loan or sell the SDK Software or create derivative works based upon the SDK software or any part thereof, except as expressly permitted in this License.
- **7.2** No DUST NETWORKS or LINEAR trademark or other identifying marks, copyright, patent or patent pending notices, or proprietary rights notices may be altered or deleted from any copy of the SDK Software or Documentation.
- **7.3** Licensee shall not circumvent the license mechanism by any means including the distribution of DLLs or other binaries that encapsulate or wrap the SDK Software's functionality for application development by non-license holders.
- **7.4** The SDK Software and Documentation shall not be used, disclosed, sold, or transmitted, except as expressly permitted herein.
- **7.5** Uses of the SDK Software or Documentation not expressly permitted by this Agreement are prohibited.
- **7.6** Licensee acknowledges that the SDK Software comprises intellectual property and is the proprietary property of DUST NETWORKS and its suppliers. Documentation and associated information provided by DUST NETWORKS (whether of a commercial or technical nature), (collectively "Confidential Information") constitute valuable and confidential property of DUST NETWORKS. Licensee agrees to protect Confidential

Information with the same confidentiality protections as are used or should be used for its own confidential information, but in no event less than reasonable and prudent care.

8. TERMINATION

- **8.1 General**. Without prejudice to any other rights, DUST NETWORKS may terminate this License immediately if Licensee is in breach of any term of this License. Notwithstanding the foregoing, DUST NETWORKS may waive this right under certain circumstances provided Licensee remedies such breach within ten (10) days of written notification.
- **8.2 CONSEQUENCES OF TERMINATION.** Upon License termination under condition of breach, Licensee shall cease to use the SDK Software and Documentation.

9. GENERAL

- **9.1 Reservation of Rights and Ownership.** The SDK Software is protected by copyright and other intellectual property laws and international treaties, and is licensed, not sold. This License confers no title, ownership or other intellectual property rights in the Software to Licensee, and DUST NETWORKS reserves to itself (and to its suppliers, as applicable) all such rights not expressly granted to Licensee hereunder.
- **9.2 Relationship.** The relationship created hereby is of Licensor and Licensee.
- **9.3** No Rights in Third Parties. This License is entered into for the sole benefit of DUST NETWORKS and the Licensee and, where permitted above, their permitted successors, executors, representatives, administrators and assigns. Nothing in this License shall be construed as giving any benefits, rights, remedies or claims to any other person, firm, corporation or other entity, including, without limitation, the general public or any member thereof, or to authorize anyone not a party to this License to maintain a suit for personal injuries, property damage, or any other relief in law or equity in connection with this License.
- **9.4 Amendments.** No amendment or other modification of this License shall be valid unless pursuant to a written instrument referencing this License and signed by duly authorized representatives of each of the parties hereto.
- **9.5 Integration**. This License is subject only to the terms and conditions contained in any existing Software License Agreement between Licensor on the one hand and either DUST NETWORKS or LINEAR TECHNOLOGY on the other hand, and to the terms and conditions contained in any existing Purchase Agreement between Licensee and either LINEAR/DUST NETWORKS for the sale of SmartMesh devices. There are no other terms or conditions, express or implied. This Agreement represents the final agreement between the parties regarding the subject of the SDK Software regardless of any prior oral or written exchanges.

- **9.6 Assignment.** Neither party hereto may assign its rights or obligations under this License without the prior written consent of the other party, which consent shall not be unreasonably withheld. provided, however, that DUST NETWORKS may assign this License Agreement to a corporate parent, subsidiary, an affiliate of DUST NETWORKS or its successor in connection with a sale of its business without obtaining consent of any party. Subject to the foregoing, each and every covenant, term, provision and agreement contained in this License Agreement shall be binding upon and inure to the benefit of the parties' permitted successors, executors, representatives, administrators and assigns. Any assignment attempted in contravention of this section will be void.
- **9.7 Claims.** Any claim or remedy for a claim made by Licensee by reason of this License or the Software shall be interpreted in strict compliance with the remedies available herein, and shall be valid and enforceable to the extent that the specific remedy complies with the License. Any and all other claim against DUST NETWORKS shall be barred and unenforceable unless provided in writing within 30 days of the date on which the subject matter becomes known to the Licensee.
- **9.8 Remedy For Material Breach.** Notwithstanding any other remedies in this License or remedies available under the law, should Licensee breach its obligations under this License regarding prohibited or restricted uses, confidentiality, proprietary or intellectual property rights, both parties agree that DUST NETWORKS, its suppliers or third party licensors will suffer immediate and irreparable harm and shall be entitled to seek preliminary and final injunctive relief in addition to any other remedies available under law and in equity. In the event a dispute occurs resulting in a legal action to address a material breach by Licensee, LINEAR/DUST NETWORKS shall be entitled to its costs of action, including but not limited to court costs, reasonable attorneys and expert witness fees, if any.
- **9.9 Severability.** Each clause in this License shall be deemed severable and separately enforceable. In the event a provision in this License is held to be unenforceable by a court of competent jurisdiction, all other provisions in the License shall remain in effect and enforceable.
- **9.10 Governing Law.** All questions concerning the validity, operation, interpretation, construction and enforcement of any terms, covenants or conditions of this License shall in all respects be governed by and determined in accordance with the laws of the State of California without giving effect to the choice of law principles thereof. The United Nations Convention on the International Sale of Goods shall not apply to any action contemplated by this License. In the event that a dispute arises, Licensee and DUST NETWORKS hereby submit to the exclusive jurisdiction and venue of the courts in San Jose, California, in the United States of America.
- **9.11 Export Compliance.** Licensee acknowledges that the SDK Software may be subject to United States export jurisdiction. Licensee agrees to comply with all applicable national and international laws and regulations that apply to the Software, including the U.S. Export Administration Regulations ("EAR"), International Traffic in Arms Regulations ("ITAR"), as well as other end-user, end-use, and destination restrictions

issued by the U.S. and other governments. Accordingly, Licensee expressly agrees not to transfer, export or re-export the Software (directly or indirectly) in contravention of such laws and regulations, and shall indemnify and hold DUST NETWORKS harmless against any liability (including attorneys' fees) arising out of Licensee's failure to comply with the terms of this paragraph.

9.12 U.S. Government End Users. The SDK Software and Documentation are "Commercial Items" as that term is defined in 48 C.F.R. 2.101, consisting of "Commercial Computer Software" and "Commercial Computer Software Documentation" as such terms are used in 48 C.F.R. 12.212 or 48 C.F.R. 227.7202, as applicable. Consistent with 48 C.F.R. 12.212 or 48 C.F.R. 227.7202-1 through 227.7202-4, as applicable, the Software and Documentation are licensed to U.S. Government end users (a) only as Commercial Items and (b) with only those rights granted pursuant to the terms and conditions of this License.
